Balloting will be used to determine the order of priority and the balloting will be performed by computer. 以抽籤方式決定選擇住宅物業的次序，抽籤將以電腦操作。</li><li>2. Registrant(s)/Company(ies) interested in purchasing any of the specified residential properties (the “<b>registrant</b>”) must follow the procedures below. 有意購買任何指明住宅物業的登記人/公司(「<b>登記人</b>」)須遵從下列程序。</li><li>3. Not more than two Registrations of Intent can be submitted by the same Registrant or Company (whether in sole name or jointly with other). Submission exceeding two Registrations of Intent will NOT be accepted. Each Registration of Intent may be used for purchase of one residential property as set out in the “Information on Sales Arrangements” (the “Sales Arrangements”). 4. Late submission or submission outside office hours will not be accepted. The order of the submission of a Registration of Intent will not have any impact on the order of priority in selecting the specified residential properties.

5. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).

6. All valid Registrations of Intent submitted before the closing time for submission will be included automatically in the balloting as detailed below. In case of dispute, the Vendor reserves its absolute right to determine whether a Registration of Intent is valid and should be included in the balloting.

7. Balloting will take place as following procedures:

  - (i) The balloting will take place on 10 April 2021 not earlier than 10:30 a.m. at Sales Office 1. The Vendor reserves the right at any time, for the purposes of maintaining order at Sales Office 1 and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the balloting. Any changes to the time and date of the balloting will be posted at Sales Office 2. Registrants will not be notified separately of such changes.

  - (ii) For the purpose of verification of identity, each registrant (if the Registrant is a company, then any one of its directors) must bring along his/her original H.K.I.D. Card(s)/Passport(s) and the original receipt of the Registration of Intent and personally attend the lobby on the G/F of Regal Hongkong Hotel, 88 Yee Wo Street, Causeway Bay, Hong Kong (the “**check-in counter**”) from 10:00 a.m. to 10:30 a.m. on 10 April 2021 (‘**check-in timeslot**’). Company Registrants must also bring along a copy of Business Registration Certificate and Registers of Directors and the company chop. Registrants shall only be eligible for the balloting after the verification of identity. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the balloting, make use of the basement, G/F and 1/F of Regal Hongkong Hotel, 88 Yee Wo Street, Causeway Bay, Hong Kong (collectively the “**Additional Venues**”) to accommodate some of the registrants by making appropriate announcement(s) at Sales Office 1 and the Additional Venues to direct registrants to the Additional Venues.

Registrants who arrive at the check-in counter beyond the check-in timeslot shall not be eligible to participate in the balloting.

- (i) Such Nominated Person(s) must be individual (whether alone or jointly with others) who has submitted a valid Registration of Intent; and
- (ii) Such Nominated Person(s) must be the immediate family member(s) (i.e. spouse, parents, children only) of the Registrant; and
- (iii) The Registrant shall provide adequate proof of the aforementioned relationship(s) to the Vendor's satisfaction (including but not limited to the production of the originals of the relevant birth certificate(s) and/or marriage certificate(s)), and the Vendor may in its sole and absolute discretion determine whether such relationship(s) is/are proven to the Vendor's satisfaction, and the Vendor's determination on whether to accept or reject requests in relation to nomination of Related Party(ies) and/or Relatives shall be final.

The Registrant may also request the Vendor on spot to add any one or more immediate family member(s) (i.e. spouse, parents, children only) of the registrant as joint purchaser(s) (if there is more than one (1) individual comprised in the registrant, then such additional purchaser(s) must be the immediate family member(s) of ALL the individuals comprised in the registrant) provided that the registrant must provide the relevant supporting documents to the satisfaction of the Vendor to prove the relationship(s) and all the aforesaid persons shall sign the Preliminary Agreement for Sale and Purchase as purchasers personally. The Vendor reserves its absolute discretion to allow or reject the registrant to add any person(s) to sign the Preliminary Agreement for Sale and Purchase.

If the registrant authorizes another person to collect the said cashier order(s), the authorized person must bring a valid authorization letter, the original receipt of Registration of Intent, copy of the registrant's H.K.I.D. Registrants will not be notified separately of the arrangements.
